The following actions were taken:

- Approved CSA No 4—Simmons & White to perform Traffic Study on Sparrow Drive, LaMancha Avenue and Ponce de Leon Street at a cost of \$16,500.00.
- Adopted Resolution No. 17-03 authorizing the Village Manager to submit an application for Transportation Enhancement Program funding through the Palm Beach Metropolitan Planning Organization for pedestrian lighting along the FPL Pathway.
- Approved Fiscal Year 2016 Comprehensive Annual Financial Report (CAFR).
- Presentation of Palm Beach County Fire Rescue Annual Report by District Chief Michael Arena.
- Adopted a Traffic Calming Policy with a change to the second resident petition in the policy from 66% to 60%.
- Adopted Ordinance No. 950 imposing a moratorium until July 31, 2017 on the acceptance of new applications/permits for the installation of above-ground wireless communications facilities within any Village rights-of-way or easements.
