**The following actions were taken:**

- Approved Amendment No. 2 for Soda and Snack Vending Machines provided by Compass Group USA.
- Approved Second Addendum to Debris Removal Services Agreement with Bergeron Emergency Services, Inc.
- Approved contract with Advanced Painting Contractors, Inc. for painting exterior of buildings on the Village Hall complex in the amount of \$36,900.00.
- Approved bid award to Green Earth Powerwashing LLC in the amount of \$49,540.05 for Sidewalk & Median Pressure Cleaning.
- Approved Resolution authorizing the five public schools in Royal Palm Beach to utilize the Official Village Municipal Seal as part of the logo for Royal Palm Beach K-12 Continuum Initiative.
- Adoption of Ordinance No. 944 regarding a Comprehensive Plan Text Amendment to the Village's MXD land use category.
- Approved first reading regarding a Zoning Text Amendment to the Village's MXD zoning district.
- Adoption of Ordinance No. 953 revising the categories of Impact Fees collected.
- Adoption of Ordinance No. 952 amending development park and recreation fees.
- Approved first reading of Ordinance No. 956 extending a moratorium from July 31, 2017 to September 30, 2017 pertaining to above-ground wireless communication facilities within rights-of-ways and easements due to the passage of HB 687.
