Village of Royal Palm Beach Council Regular Meeting was called to order at 7 p.m. on July 20th

The following actions were taken:

- Tentative adoption of the proposed millage rate of 1.9200 and approved public hearings on September 7, 2017 at 7:00 p.m. and September 19, 2017 at 7:00 p.m. at the Village Meeting Hall.
- Approved two final plats—Shoppes of Village Royale and RD Royal Palm Beach, LLC SR 80 Apartment Complex.
- Approved Second Addendum to the Law Enforcement Service Agreement with PBSO.
- Adopted Ordinance No. 956 extending a moratorium from July 31, 2017 to September 30, 2017 pertaining to above-ground wireless communication facilities within rights-of-ways and easements due to the passage of HB 687.
- Approved first reading amending Chapter 26—Zoning—definitions for "Marijuana", "Medical Marijuana Retail Center" and "Medical Marijuana Treatment Center; prohibit Medical Marijuana Treatment Center Dispensing Facilities; provide updated requirements for Medical Marijuana Treatment Center; eliminate Medical Marijuana Retail Centers as Special Exception Use in CG, and IG and add as Permitted Use in the IL and IG zoning districts.
- Approved first reading of Ordinance No. 957 amending the Charter to adjust dates for qualifying for municipal elected office.
- Approved first reading of Ordinance No. 958 amending Chapter 8—Elections to adjust dates for qualifying for municipal elected office,
