The following actions were taken:

- Approved a setback variance at 1072 Grandview Circle.
- Approved variances for rear parking spaces, number of spaces, wall height, along with site plan, special exception and architectural approval for Hunt Midwest Senior Housing Facility located at 10651 Okeechobee Blvd.
- Abandoned 50 foot drainage easement along Tract B within the LaMancha Plat.
