1. Approval of the minutes of the Council Regular Meeting of February 15, 2018. (Village Clerk)
2. Approval of bid award and authorization for the Village Manager to enter into a contract with Pooltek of the Palm Beaches, Inc. the sole responsive, responsible bidder for Waterfall Repairs in Veterans Park in the amount of \$59,962.87. Adoption of Resolution No. 18-04, a resolution of the Village Council of the Village of Royal Palm Beach, Florida, authorizing the Village Manager to submit an application for local initiatives program funding through the Palm Beach Transportation Planning Agency for the construction of a pedestrian and roadway extension of La Mancha Avenue to Okeechobee Boulevard with a signal at the Okeechobee Boulevard intersection.
