**Village of Royal Palm Beach Council Regular Meeting was called to order at 6:30 p.m. on Thursday, March 1st.**

**The following actions were taken:**

- Approved bid award in the amount of \$59,962.87 for Waterfall Repairs in Veterans Park to Pooltek of the Palm Beaches, Inc.
- Approved the purchase of software licenses and professional services to upgrade Superior (H.T.E.) Public Sector Mgmt Software to NaviLine Window’s graphical thin-client interface.
- Approved Special Event Permit for the Village to hold West Fest from March 9-11 at Commons Park.
- Approved Res. 18-04 authorizing the Village Manager to submit an application for local initiatives program funding through TPA for construction of a pedestrian and roadway extension of LaMancha Ave to Okeechobee Blvd. to include signal at Okeechobee intersection.
- Approved Professional Services Agreement with My PR Guru to perform a Comprehensive Communication Plan.
- Adopted Ordinance No. 969 revising placement, maintenance and use of telecommunications facilities in Village rights-of-way.
- Adopted Ordinance No. 970 amending the definitions of dangerous and vicious dogs.
