Village of Royal Palm Beach Council Regular Meeting was called to order at 6:30 p.m. Thursday, November 15, 2018

The following action was taken:

- Adopted Res. 18-33. approving budget amendment for Fund 001 and 407 for FY 17/18 budget. Amendment represents the year end (13th period) budget adjustment and appropriates \$326,000 from General Fund Revenues and \$11,000 from Stormwater Revenues to Legal, Police and Public Works.
- Approved purchase of a Kubota R630/ loader and other attachments from Florida Coast Equipment not to exceed \$85,000.
- Approved the purchase of one vehicle from Duval Ford in an amount not to exceed \$25,137.00.
- Approved the purchase of one vehicle from Duval Ford in an amount not to exceed \$45,829.00.
- Approved Seasonal Vendor Permit for Publix to sell Christmas trees at 11977 Southern Blvd. from November 23rd– December 23rd.
- Approved Special Event Permit for the Village to hold Winter Festival at Commons Park on Dec. 1st from 1:00 p.m.-9:00 p.m.
- Adopted Res. 18-34 and Application No. 18-89—Modification to a Council Imposed Condition. An application by RD Royal Palm Beach, LLC to allow for a phasing plan regarding the construction of buildings, fencing and landscape installation for a 392 unit multi-family residential development on the south side of Southern Blvd. north of Acme Road and west of SR 7.
- Adopted Res. 18-32 accepting conveyance from Lennar Homes, LLC to the Village known as "Tract Rec-1 of the plat of Crestwood North consisting of 251,918± square feet at the northwest quadrant of Crestwood Blvd. and the M-1 Canal.

- Approved a Temporary Construction Access and Use Easement Agreement between the Village and Lennar Homes LLC for the use of Tract Rec-1 of the plat of Crestwood North.
- Adopted Ord. 981 amending Chapter 17. Offenses and miscellaneous provisions. At Section 17-13 Public Parks-Hours of Operation in order to add new time limit requirements for park facility usage and new regulations relating to private instruction and teaching lessons in Village parks.
- Adopted Res. 18-31. Amending Schedule of Fees & Charges in order to provide for civil penalties for violations of Sec. 17-13(2) relating to time limits on park facility usage and private instruction and teaching classes at Village parks.
